NORTHEAST INDIA ISSUES AND POLICY RESEARCH

ABSTRACT

Northeast India located in the easternmost fringe of the Indian subcontinent is delineated by the Himalayas in the north and Arakan Yoma in the east and is straddled by the Ganges-Padma plains overlooking the Garo, Khasi, and Jaintia hills in the south alongside the undulating plains of Tripura and the Chittagong Hill Tracts that border Mizoran at the bottom. The region is today in a "state of exception" with disputes ranging from the resouitarized borderlands, and ethnonationalism. The challenges are buttressed by growing levels of sociopolitical unrest, migration paranoia, and ecological risk elicited by the proposed construction of big dams, mining, and people's aspiration for development and modernization. There are eight states in Northeast India if we include Sikkim. Both the local and immigrant communities (for example, the indentured tea tribes of Assam) are undergoing insurmountable challenges where the policymaking needs to be reframed following a "pluriversal", "anti-colonial", "decolonial", "postdevelopment" and "convivial" perspective for dispute resolution (for example, the ongoing ethnic friction in Imphal valley).

This roundtable is aimed at discussing collegially current issues and challenges of Northeastern states and how to resolve these through policy research which could include the voices of all marginalized groups historically conditioned by colonial epistemic violence and postcolonial experience of "state making". Scholars who are working among communities in the Northeast region will share their experiences through narratives on how they face challenges in conducting research, build solidarity with communities at the margins, and foreground perspectives from below. They will be encouraged to voice the current situation in their states and give suggestions which will be discussed in a participatory mode and ways it can inform policy-making at the regional, national, and international forums.
